Highlights / Changes for 2017

The Metric Century (Plus):

The basic 32, 45, and 62 mile routes will remain the same as in 2016. Similar to 2016, the Century Option will be route extensions between rest stops on the 62 mile route. These route extensions will remain unmarked and unsupported - JBC will be providing maps and cue sheets only, no SAG support will be provided. The ride start and stop times will remain the same as in the past, so Century riders **must** complete the ride by 4:00. Ran into a vendor at the Harper College swap meet last weekend who rode the Century Route in 2016, and had was glad the Club added the Century Route.

Tee Shirt:

Going to try something new for 2017 - looking for design ideas from the members for the tee shirts. Please send any ideas for the tee shirt design to jbc4thride@gmail.com for our review. Send in photos of you fav tee short design, something you saw on a web site, or just a description of an idea that we can work with. All ideas will be considered.

Tee shirts selection was normally done at the Chili Bowl, but we are going to try something different this year. With so many members not being able to attend the ChiliBowl, thought it would be better to have all members have a voice in the tee shirt selection. We will be sending out the design thru GG for members to vote on their fav design - expect to see an e-mail with the tee shirt designs something early March. The design will be posted on our web site after April 1st.

Any 4th volunteers who did not get a tee shirt in 2016, please let me know. Think there was a couple of volunteers from Platteville who did not get 2016 tee shirts.

We switched from cotton to poly tee shirts in 2016, and am planning to stay with poly for 2017.
